5. INFORMATIONAL ITEMS

a. SABGSA Executive Director Updates

- The GSP Annual Report is underway. SABGSA is drafting the Management Action Implementation Approach section. GSI Water Solutions, Inc. will present the draft report at the February 18, 2025 Board meeting.
- SABGSA requested \$21,232.13 from the SABWD on January 9, 2025 to cover invoices received this month.
- SB1156 Form 700 Filing Requirements. SABGSA Board (and Alternates) and Executive Director are now required to file Form 700 with the Fair Political Practices Commission by April 1, 2025. This is in addition to filing Form 700 with the County of Santa Barbara by April 1, 2025. SABGSA will track both submittals on the Board Training/Certifications Report.

b. San Antonio Basin Water District (SABWD) Update

The SABWD Board of Directors met on January 21, 2025. Executive Director Donna Glass reported the following.

- At the Special Board of Supervisors meeting on October 15, 2024, three (3) directors, Kevin Merril, Randall Sharer, and Andrew Read, were appointed to the Board of the San Antonio Basin Water District in lieu of election with terms expiring in December 2027. Kevin Merrill and Randy Sharer will continue as President and Vice-President, respectively. District Manager, Donna Glass was appointed as Secretary and Victor Schaff will continue as Assessor, Tax Collector and Treasurer.
- Wallace Group reviewed the Re-Evaluation of the Irrigated versus Non-Irrigated Lands with the Board and addressed questions.
- As of January 16, 2025, \$472,977 or 84% of the 2024-25 Assessments has been collected.
 The remaining balance is \$87,074. Payment reminders were sent out on January 3, 2025,
 and become delinquent on February 3, 2025. A transfer in the amount of \$25,000 from the
 Operating Account to the Investment Account, California CLASS with an Average Monthly
 Yield of 4.63%, was approved.
- The SABWD Board approved a fund request from SABGSA for \$21,232.13 to cover invoices received this month.

6. PUBLIC HEARING

a. Consider Ordinance No. 25-001 to Adopt and Implement a Well Metering and Groundwater Extraction Reporting Program

During the public comment period, questions were raised regarding a pathway and requirements for an inactive and/or abandoned well to be exempt from SABGSA's Well Metering and Groundwater Extraction Reporting Program. The current version of SABGSA's proposed Rules and Regulations related to the Ordinance 25-001 does not contain an exemption clause nor does it outline the conditions and process for a potential exemption.

Motion by *Director Merrill*, second by *Director Chabot* to direct SABGSA legal counsel to work with SABGSA staff to revise Ordinance 25-001 to address conditions and requirements under which a well could potentially be exempt and present the proposed revisions at the February 18, 2025 board meeting.
